7. What dividend does Investcorp Capital expect to pay and when?

- Investcorp Capital is targeting to pay an annual dividend of at least 8% of net asset exposure.
- Dividends will be paid semi-annually.
- The first semi-annual dividend payment is expected in February 2024 and the second in October 2024.
- If dividends in any period are less than the intended targeted amount, Investcorp Group will forgo its right to receive dividend payments to pay a pro rata amount to other shareholders, with the right to catch up in subsequent financial years.

14. Can I apply for shares in more than one tranche?

- Subscribers may apply for offer shares in only one tranche either in the First
 Tranche or in the Second Tranche. In the event a person applies for offer shares
 in more than one tranche, the Receiving Banks and the Joint Lead Managers
 may disregard one or both of such applications.

15. What is the minimum and maximum subscription size?

• First Tranche (pro rata allocation tranche):

- The minimum application size for subscribers in the First Tranche (pro rata allocation tranche) is AED 250,000 with any additional application in increments of AED 1,000.
- Investor to prefund the subscriptions as at the time of submission of application.
- There is no maximum application size for subscribers in the First Tranche
- Allocation will be done on a pro-rata basis and announced after the closing of the Offer Period and after determining the final Offer Price.
- SMS notification regarding the final allocation will be sent to subscribers in the First Tranche by 14 November 2023.
- Second Tranche (discretionary allocation tranche):
 - The minimum application size for the subscribers in the Second Tranche (discretionary allocation tranche) is AED 5,000,000.
 - There is no maximum application size for subscribers in the Second Tranche.
 - Allocation will be done at the discretion of Company and the Selling Shareholder.
 - o Post allocation, Subscriber to make payment within the set timelines.

19. If I do not receive the full amount of shares I subscribed to, how will I be refunded?

• By no later than 14 November 2023 (being within five (5) working days from the Closing Date of the Second Tranche), the Offer Shares shall be allocated to

subscribers and, on 14 November 2023, the surplus subscription amounts and any accrued return/profit resulting thereon, shall be refunded to subscribers in the First Tranche by the relevant Receiving Bank. The surplus amounts and any accrued return/profit thereon will be returned to the same Subscriber's account through which the payment of the original application amount was made. In the event payment of the subscription amount is made by a certified bank cheque, these amounts shall be returned by sending a cheque with the value of such amounts to the subscriber at the address mentioned in such subscriber's subscription application.
